#### **NOTICE OF PUBLIC HEARING**

The Willow Creek Sewer District will hold a public hearing on April 30th, 2024. The public hearing will begin at 6:00 p.m. at the Willow Creek School at 407 Main St., Willow Creek, MT, 59760. The District has scheduled the hearing to obtain public comments regarding the proposed improvements to Willow Creek's wastewater system. With assistance from Great West Engineering, the District is preparing a wastewater preliminary engineering report (PER) along with applications for funding from a combination of the Montana Department of Commerce, Montana Department of Natural Resources and Conservation, the Community Development Block Grant program, the US Department of Agriculture Rural Development Program, and the Department of Environmental Quality's Clean Water State Revolving Fund Program.
